### **OVERVIEW**

Harry Matovu was nominated as Silk (QC) of the Year for International Arbitration in the Legal 500 Awards 2020. He is a noted advocate with a high-profile commercial practice, including energy and natural resources, finance, civil fraud, insurance/reinsurance and arbitration. He acts as both counsel and arbitrator under ICC, LCIA, UNCITRAL and ARIAS Rules, as well as ad hoc references. Harry is instructed as Leading Counsel in major energy, infrastructure and insurance/reinsurance disputes. He has been involved in numerous insurance and reinsurance arbitrations (including the 1990s Lloyd's disputes, the US personal accident spiral disputes, and claims across many classes of US and UK casualty and other business). He has also recently arbitrated a wide range of commercial disputes, including claims concerning the control of a leading energy conglomerate in Africa, a major telecoms dispute, large infrastructure projects in Zambia and Mozambique and major share sale and joint venture disputes.

#### STYLE AND APPROACH

Harry Matovu has been described in the legal directories as "a really classy performer". He has a deep knowledge and long practical experience of commercial arbitration. As an arbitrator, he focuses on the needs of commercial parties for efficient, pragmatic and cost-effective processes, as well as thorough preparation and understanding of the issues by the tribunal, and sound and commercially-aware decisions delivered without undue delay after proper consideration. Having practised as a commercial lawyer for 30 years from one of the leading commercial sets at the English Bar, he has a detailed knowledge

of commercial law and disputes. He is noted for his approachability, engagement, thoroughness and complete lack of pomposity. As a presiding arbitrator, he ensures control of the reference through regular contact with the legal representatives, and his long experience as a commercial advocate and QC gives him a calm authority and control of the conduct of hearings.
